#### 7. CHAIRMAN'S REPORT

Regarding the ongoing problem of flooding gardens and surface water in West Place, I have been contacted by Shepway District Council's Asset Engineer, Mr Peter Shaw, who told me that he has been allowed sufficient funds to cut back the overhanging trees and dredge the ditch which runs behind West Place into which the rain and surface water drains from the estate. He feels that this may help reduce the winter ground water level. Mrs John Paine has agreed to allow his contractors onto her land to do this work in early February.

It has been necessary to telephone Ann Norton about the badly damaged verges in Salters Lane. These have had tarmac placed in the potholes left by the bridge contractors – after we were assured that they would be reinstated with soil – which has encouraged the refuse lorry drivers to cut to within 6" of the hedge and fence of number 36 West Place with no attempt being made to negotiate the bend. Ann Norton said she would investigate and get back to me. I await her call.
